01-17-2017 COMMISSIONER PROCEEDINGS

The Board of County Commissioners met at the above date beginning at 9:00 a.m. Those present were Chairman Terry Wolf, Members Aaron Anderson, Fred Frandson and Clerk to the Board Mary Grace Strauch. The meeting was opened with the Pledge of Allegiance led by Planner David Anderson.

A motion was made by Commissioner Anderson and seconded by Commissioner Frandson to approve the minutes for the January 3, 2017 meeting. Motion carried.

Planner David Anderson and Road and Bridge Superintendent Randy Chenoweth met with the board to discuss the width of the new Winchester Bridge. Approval was given to proceed with a 22 foot bridge with steel girders and a pedestrian rail for walkers. A draft of the report will be presented before final approval.

Road and Bridge Superintendent Randy Chenoweth reported that the crew continues to do snow removal as needed and maintenance work. It was decided not to pursue the snow fence at the septage site but to possibly plant trees in several areas for a natural snow fence. The board would like Randy to present a priority list for upcoming projects for 2017.

Centsible Nutrition Director Cindy Aguilar, Extension Educators Phyllis Lewis and Caitlin Young, 4-H Youth Educator Amber Armajo and Administrative Assistant Janet Benson presented to the board upcoming events that are being or going to be held throughout the county with the extension office. Discussed was REAL foods class, Westi-Ag Days, the BIGM program through 4-H. Further discussion was held on approaching middle school and high school students about serving on county boards as an advisory member. Amber and Commissioner Anderson will continue to work on this project.

Public Health Nurse Amanda Heinemeyer reviewed with the board the 2017-2020 Title X funding application. Discussion was held on having available to employees an activity tracking feature for Fitbits and similar devices through the Wyoming Health Fair website. The question will be asked to the employees before pursuing this through the Wyoming Health Fairs

Youth Alternatives Director Sarah Garcia and Grant writer Anna Venable met with the board to review the Safe2Tell program that was held recently. Additional information can be found through the Youth Alternatives office.

Myriah McCullogh auditor with Carver, Florek and James reviewed with the board the annual audit report. Myriah reported that cross training between employees in the Treasurer's office and County Clerk's office needs to be done. At this time staff is limited on knowledge of every function that the treasurer and the clerk currently do. The board will meet with the respective offices and further discuss. Also discussed was the lack of record keeping with the Fair board. This is a problem that has been occurring for several years.

The board met at the Homeland Security office at the fair grounds with Building Maintenance Manager Tom Schmeltzer, Homeland Security Director Jeff Schweighart, 4-H Educator Amber Armajo, and RT Communications Representative Casey Rice to discuss what type of projector or

A motion was made by Commissioner Anderson and seconded by Commissioner Frandson to offer the position Youth Alternatives part time grant writer to Sheri Gunderson. Motion carried. Sheri accepted the position and will begin to work with Anna and Sarah immediately.

The board gave an overview of the issues with the aquatic center maintenance endowment agreement with Anna Venable.

Building Maintenance Manager Tom Schmeltzer and Ron's Sanitation owner Ron Harvey met with the board to discuss issue of a sewer back up that occurred last week. It was discovered that there are roots in the line behind Pioneer Square that the city is working on cleaning out. Discussion was held on possibly replacing our sewer line to the Robertson Ave line. There was no decision made on this issue.

County Attorney John Worrall reported to the board that the school district will not have any discussion of the aquatic center maintenance endowment agreement at their upcoming meeting. The commissioners will invite all to attend their next meeting to discuss the concerns and issues at their Feb. 7, 2017 meeting. Further discussion was held on what information will be given to the forensic auditor. John will hand deliver the documents that have been acquired by the fair board.

A phone call was placed to Sandy Beck in regards to who can approve time sheets and invoices as needed with the absence of Director Mike Bryant. A motion was made by Commissioner Anderson and seconded by Commissioner Frandson to allow Sandy Beck to approve all timesheets and invoices until the return of Mike Bryant. Motion carried.
