## NOTICE TO BIDDERS

Sealed bids entitled **“TEN SLEEP TRANSFER STATION”** will be received by DONNELL AND ALLRED, INC. at Donnell and Allred, Inc., 908 Big Horn Ave., P. O. Box 638, Worland, WY 82401 until **MONDAY, MAY 23, 2016**, at 4:00 PM Mountain Daylight Time for the contract with the **TEN SLEEP SOLID WASTE DISPOSAL DISTRICT** for a **NEW TRANSFER STATION INCLUDING SITE WORK, TRANSFER BUILDING, SCALE AND SCALE BUILDING, SEWER SYSTEM, NEW 3” WATER LINE FROM TOWN WATER MAIN TO NEW FACILITY INCLUDING WATER BOOSTER PUMP AND RELATED WORK.**

It is assumed that all bidders will have copies of the Wyoming Public Works Standard Specifications - 2001 Edition.

Bid Security shall be made payable to OWNER, in an amount of not less than five percent (5%) of the Bidder's maximum Bid price and in the form of a cashier's check or a Bid Bond issued by a Surety, meeting the requirements of the Instructions to Bidders. The Bid Security of the Successful Bidder will be retained until such Bidder has executed the Agreement and furnished the required Contract Security, whereupon it will be returned; if the successful Bidder fails to execute and deliver the Agreement and furnish the required Contract Security within 30 days of the Notice of Award, OWNER may annul the Notice of Award and the Bid Security of that Bidder will be forfeited.

A pre-bid conference will be held at Ten Sleep Senior Center, 204 2nd Street, Ten Sleep, WY on Monday, May 09, 2016, at 10:00 AM local time. It is recommended that all bidders interested in this Project attend the pre-bid conference.

Bids shall be submitted on proposal forms provided in accordance with the contract documents.

Each bid must be submitted in a sealed envelope, addressed to DONNELL AND ALLRED, INC. and mailed to P.O. Box 638, Worland, WY 82401 or hand delivered to 908 Big Horn Ave., Worland, WY 82401 and must be plainly marked on the outside with the project name.

All bids duly received by Monday, May 23, 2016, at 4:00 PM Mountain Daylight Time, will be publicly opened and read shortly thereafter. The TEN SLEEP SOLID WASTE DISPOSAL DISTRICT reserves the right to reject any and all bids.
