City Engineer Representative Donnell presented the Varney Subdivision for property located at 113 Sunset Drive. The Board of Adjustment & Planning Commission approved the subdivision at their last meeting. This is a simple subdivision dividing the Varney property into two (2) parcels, one lot will include the house and the other will be vacant property. Both parcels have access to water and sewer.

Donnie Bjorhus with Green Hills Golf Course informed the Motion: to approve the simple subdivision requested by Eric Var-

Superintendent of Public Works Nick Kruger informed the Council that Gail Carver would like to place the Senior Banners on the decorative light poles again this year. The WYDOT permit is ongoing so if the council agrees without motion, the banners will be placed the first part of May. The Council agreed by consensus. The crew is again working on potholing; however, the weather is popping the potholes back open again. Typically, the city uses 4-6 thousand lbs. of emergency patch, as of this Friday we will have used 20 thousand lbs. and expect to order more. The crew is continuing to repair 15th Street in preparation for the street improvement project later this spring or summer. We also took advantage of the weather and removed the old white pumphouse building and pipe in Newell Sargent Park. The infrastructure was incredibly old and if the pipe had failed the water from the canal would have flowed back into the park. The Streetsweeper was out and will be out again, weather permitting. The crew will start work in the alleys next week as we have received several complaints.

City Engineer Representative Donnell updated the Council on the Request for Proposal (RFP) draft for design engineers for Washakie Avenue Project under the Urban Systems Fund. That RFP should be sent out within the next few weeks. City Engineer Representative Donnell is also working on a TAP grant for the Safe Routes to School (SRTS) program to upgrade the signage and flashing lights for the school. Chief of Police Elliott and Superintendent of Public Works Kruger have been working on this project and on the location of the lights to secure the best results for solar power.

City Attorney Kent Richins requested an executive session at the close of the meeting to discuss possible litigation.

Chief of Police Gabe Elliott reported that at least one of the flashing lights for the school is non-functioning and replacement parts are not available. In looking at the various locations yesterday, we found better locations for a few of the signs. Discussion followed as to if the TAP grant will only cover equipment replacement. City Engineer Representative Donnell stated that this application would be only for signage and equipment replacement and may be a phased project if additional items are added in the future such as curb, gutter and sidewalk. Chief of Police Elliott reported that this Thursday the Middle School kids will be job shadowing at the police department. Hopefully, we can get some of them interested in a law enforcement career.

Airport Manager Lynn Murdoch informed the Council that the east gate has been installed except for power. The gate should be functional within a couple of weeks. The Wildlife Fence Project is 90% complete with the contractor still having issues with the weather. Airport Manager Murdoch is working with the Flight Club for the Fly In and noted that the city received grant money from the FAA for the event.

Mayor Gill noted that the Municipal Court Report for March 2023, the Building Permit Summary for March 2023, and the WCCC Budget for FY23-24 are in the Council packet for review.
