WP Demand, \$139.90; Railroad MGT Co III LLC, License Fees, to discuss the proposed resolution for consideration at the next Council meeting. This resolution will increase the fees at the cemetery. Councilmember Worley read a statement by Councilmember Pete Calderon, who was absent. The statement is as follows: "I would like to go in the direction of cutting spending this fiscal budget year versus raising the fees on services. Raising fees on services can be seen as a tax. Had I been present tonight, I would have voted against raising the cemetery fees. I would prefer a conservative fiscal approach until next year. I disagree with the Council following the advice of the auditor who recommended raising the fees of our services, when we can look at our budget during the work sessions as a council and discuss what other departments to pull from to cover shortages as mandated by state statute. I value everyone's opinion and I understand there will be disagreement. Thank you for allowing me to voice my concern." City Attorney Richins stated that the cemetery runs in the red using funds from the General Fund to subsidize it; "there is no way we could charge enough to maintain a proper cemetery.' Councilmember DeMunbrun asked Clerk/Treasurer Glanz to find out the last time the fees were increased for further discussion at the council work session. Mayor Gill stated that he could not remember the last time the cemetery fees were increased over the last ten (10) years and cautioned that with the current inflation it is easy to get behind. City Attorney Richins stated that from the auditor standpoint, the city is required to have a certain percentage of reserves in the enterprise funds. Discussion followed on possible rate increases as noted by the auditor. The Council will discuss the proposed cemetery fee increase and reserve strength at the council work session.

> City Engineer Representative Mike Donnell is working with WYDOT to get the Request for Proposal (RFP) out for the Washakie Avenue Project design. The consultant services policy, that is required by WYDOT and must be followed in this RFP process, is 28 pages long. The Urban Systems Funds are federal and with federal funding there are always additional requirements that must be met.

Chief of Police Gabe Elliott informed the Council that this is the time of year that historically there is an increase in offenses and the police department has seen that in the last couple of weeks. The police officers have done a great job, with a lot of young officers. All the officers that are available will be at the next Council meeting for introduction. This Saturday is the Shop with a Cop Program with the Worland Police Department, Washakie County Sheriff's Department, Wyoming Highway Patrol and Bureau of Land Management Rangers who will be assisting youth in purchasing gifts for family members. Chief of Police Elliott mentioned the many volunteers who will be wrapping presents. The Parade of Lights went well, Chief of Police Elliott thanked the public works, airport and city hall personnel who helped with the parade.

Director of Public Works Nick Kruger reported that the city crew is working on the irrigation project at Newell Sargent Park, installing subterranean piping. The water table is still high, so the project is taking longer than expected. The concrete will be poured tomorrow, and the crew should be done with the excavation within a week.

Mayor Gill noted that the Municipal Court Report, Building Permit Summary and Golf Course Monthly Financial Reports for November, 2023 are in the Council packet for review. Also in the packet is WBI Pipeline information.

There being no further business to come before the Council, Mayor Gill asked for a motion to adjourn.
