be worked on this spring. Discussion was held on the Hanover Irrigation District and the placement of a pipe on Lane 17 within the county right of way. The board will meet at the location for further discussion. Flow fill will be placed on the width of the county right of way by the county. Two right of way easements with RT Communications were reviewed. Discussion was held on contacting WYDOT about an area that was repaired last year on the Lower Nowood that needs additional work completed this spring. Discussion was held on extending a double invert on Road 54 with an agreement with WYDOT to help with dust control. Commissioner Anderson will contact Randy Merritt with WYDOT to receive a price on the cost for ½ to 1½ miles. Discussion was held on the fire signs and the placement within subdivisions with Planner David Anderson. Keith and David will work on a policy for the signs and discuss further at the next meeting.

Building Maintenance Manager Tom Schmeltzer reported that the panel at the Law Enforcement Center regarding the fire alarm must be tested each year and he has contracted to have this completed. Discussion was held on the pressure reduction valve at the Septage Site and the possibility of either purchasing a back-up value or possibly putting a pressure reduction valve inside the building. A back-up valve is \$4,500 to \$6,000. Tom will discuss further with the planner before moving forward. One estimate was received for carpeting at Public Health. Tom will obtain one more estimate before a decision is made.

Amanda Heinemeyer reported that there have been no measles cases in Wyoming reported yet. The monthly narrative was reviewed.

Bids were opened for a new server. Two bids were received as follows: Ptolemy \$17,638.85 and Y & S Technologies \$22,251.00. The bids were reviewed by IT Director Bill Murphy. After the review a motion was made by Commissioner Wolf and seconded by Commissioner Anderson to accept the low bid with Ptolemy for \$17,638.85. Motion carried.

Homeland Security Director Jeff Schweighart, Conservation District Director Tori Dietz, Mayor Jim Gill, Clerk Treasurer Tracy Glanz, City representatives Brian Burky, Randy Adams, and on the phone was Army Corp representatives Greg Johnson and Tim Goode to discuss the Section 205 Flood Risk Management Study estimated costs for the study to completed. Discussion was held on the 1,000,000.00 estimated cost. By moving forward with a letter from a sponsor the Army Corp of Engineers can complete their assessment scope of the actual costs of a feasibility study and what the cost will possibly be to the county and the City of Worland. The Army Corp of Engineers assessment scope is initiated with up to \$100,000 in federal funds that is not cost shared with the sponsor. There will be no expense to the sponsor during the assessment scope. Once a feasibility study cost share agreement is signed there would be in-kind and actual money needed for the feasibility study. Before signing the agreement there will be much discussion held on actual costs, and what could be considered in-kind contributions to the project. In-kind contributions could be GIS parcel maps, assessor data, economic data, and survey data. A motion was made by Commissioner Anderson and seconded by Commissioner Wolf to send a letter requesting that a scope be completed of a feasibility study for the Flood Risk Management Study at no cost at this time to the county. Motion

Homeland Security Director Jeff Schweighart reported that he will be working with Mike Siegfried regarding the ham radios. Code red results were discussed and at this time 88% connectivity with 4012 users in the database. Jeff will check to see if the current invoice can be paid in quarterly payments.

Ambulance Director Luke Sypherd reported that one of the ambulances broke down in Billings and repair work was completed. There are 6 people interested in the advanced EMT Training. Rico Flores will be the EMS Capitan. Discussion was held on removing a wall where the shower area is located at the ambulance bay. Luke has discussed with Tom Schmeltzer and it is possible to remove the wall. This will allow for additional storage space. Luke will receive additional cost estimates before moving forward. At this time the revenues for the ambulance service are below what was estimated. It is partially due to issues with selfpay patients. There is over \$107,000 that has not been collected. The board suggested discussing this issue with County Attorney John Worrall.
