Mayor Gill asked City Attorney Kent Richins to update the Council on the bid for the Web Based HVAC Control System. City Attorney Richins informed the Council that a bid was received six (6) days after the bid opening on June 21, 2022. The bid was from LONG Building Technologies, Inc. for \$57,621.00; a bid bond was included with the bid. The purpose for the bidding process is to protect taxpayers by approving the lowest bid and to allow all qualified bidders to bid. City Attorney Richins stated that from a legal perspective these objectives have been met as the bid is within budget and recommended approval of the bid pending questions from the Council. Discussion followed on what would be done to update the system and the timing of the project.

Donnie Bjorhus with Green Hills Golf Course reported that Memorial Scramble held on June 11, 2022 had eleven (11) teams and the DeBonya Tournament was held June 17-19 with fortytwo (42) teams with players from several states. Junior golf lessons started June 28 and will run through July 14; this program is supplemented by the Worland Rec District. City Attorney Kent Richins presented Ordinance #864 for third and final reading:

AN ORDINANCE OF THE CITY OF WORLAND, WASHAKIE COUNTY, WYOMING, AMENDING THE OFFICIAL ZONING MAP PROVIDED FOR IN WORLAND CITY CODE SECTION 24-8 BY RE-ZONING THE REAL PROPERTY DESCRIBED AS 2313 AND 2401 BIG HORN AVENUE (WORLAND CAMP-GROUND) FROM A MANUFACTURED HOUSE RESIDEN-TIAL (MHR) ZONE TO A GENERAL BUSINESS (GB) ZONE. ALL ORDINANCES OR PARTS OF ORDINANCES IN CON-FLICT HEREWITH ARE HEREBY REPEALED.

Motion: to pass, approve and adopt Ordinance #864 on third and final reading.

By: Councilmember Worley. Second by: Councilmember Lombard. Vote: The motion passed unanimously.

Superintendent of Public Works Nick Kruger informed the Council that he received the results from the audit of the Industrial Pretreatment program; there are a few corrective items, nothing significant. After a complete review of the audit, a full report can be provided to Council. There have been a couple of water leaks, one in the 900 block of West River Road and on the 400 Block of Railway; the city will have to hire a contractor to dig the one on West River Road as our equipment is not big enough and the water line is deep. The bids will be coming out for the 1-ton pickups this month. WBI did an excellent job at the Golf Course Pond, re-establishing the shoreline and cleaning up the area. The city will reseed and water the area. The SCADA system has been updated; this is the remote water well monitoring system. Phase I of the project is complete and we will be working on Phase II this budget cycle. This update replaces a 1994 system.

City Engineer Representative Donnell reported that the walls on the city shop pole building are going up and the alley behind ACE Kennedy Hardware should be done within the next several weeks. After completion of paperwork, the mid-block fire hydrant replacement project will start. The plans and specs for the 2022 street project are almost complete and the project will tentatively be advertised for bid on July 14 and July 21 with a bid opening on July 27, 2022 and a recommendation to Council at the August 2, 2022 meeting. City Engineer Representative Donnell passed around the street projects map, this map includes projects paid for by the one cent general purpose tax since 2017.

City Attorney Richins stated that the hearing date will be July 25 for the Veile Mortuary cases, the garage extension and placement of the crematorium. The Board of Adjustment and Planning Commission (BAPC) will preside over the hearing. The hearing will be at City Hall and will start at 4PM and could last

Chief of Police Gabe Elliott updated the Council on the 4th of July incidents; indicating that there were a lot of warnings, but no citations issued. The Fire Department did an excellent job at the gravel pits as there were several small fires. Last week, the tactical team did a walk through at Sunlight Federal Credit Union, there are quite a few security features in the bank; the tactical exercise at City Hall will be on July 28, 2022. The bid has been advertised for the police department vehicle(s) with the bid opening on July 19, 2022.

Airport Manager Lynn Murdoch reported that the Fly In at the airport was well attended with over 200 pancakes served. Airport Manager Murdoch and Clerk/Treasurer Glanz will be attending Blackcat Training and the WAICIP meeting in Thermopolis on August 2, 2022. The WAICIP meeting will determine funding for future projects at the airport.

Mayor Gill noted that the Municipal Court Report and Building Permit Summary for June 2022, and a letter to WYDOT from a concerned citizen were in the Council packet for review.

There being no further business to come before the Council, Mayor Gill asked for a motion to adjourn.
