### WASHAKIE COUNTY COMMISSIONER PROCEEDINGS July 9, 2024

The Washakie County Board of County Commissioners met at the above date beginning at 9:00 a.m. Those present were Chairman Aaron Anderson, Commissioners Terry Wolf and Morgan Martinez and clerk to the board Lily Rakness Parra. Also present were Mike Bies, Laura McDonald, Dr. Jim Gilman and Stephanie Kowalczyk with the Washakie County Historical Preservation Board. The meeting was opened with the Pledge of Allegiance led by Dr. Jim Gilman.

A motion was made by Commissioner Martinez and seconded by Commissioner Wolf to approve the minutes of the June 30, 2024, meeting. Motion carried.

Mike Bies with the Historical Preservation Board gave an update to the BOCC. He advised that they were able to receive the final draft for the downtown project. They have not yet received the distribution, but they are moving forward with the project and will look at getting a final document to the nominating committee to be on the National Register.

Building Maintenance Manager Breck Buer gave an update to the BOCC. He advised that they had crews out working on the show room area for the judges out at the fairgrounds. He also advised that Dan Mattis with the BBQ Bluegrass committee would like to donate a structure for the beer trucks to utilize on the southwest area of the grass where the bands play. The BOCC advised they would like to go out and look at the area for the structure. Buer advised that they were finishing up a few repairs at the VA building as well.

A motion was made by Commissioner Wolf and seconded by Commissioner Martinez to appoint Sarah Radabaugh to the Library Board and re-appoint James O'Connor and Mike Bies to the Historical Preservation Board. Motion carried.

Commissioner Wolf to appoint Audra Neighbors as an ex-officio member of the Hospital Board. It was discussed that going forward the BOCC would like to have a recommendation from the Hospital Board for the ex-officio member. Motion carried.

A motion was made by Commissioner Wolf and seconded by Commissioner Martinez to approve the FY2024/2025 Budget as advertised. Motion carried.

Road and Bridge Superintendent Stuart Bower gave an update to the BOCC. He presented two ROW applications for Dan Frederick to the BOCC. He also advised that he would like to order three or four signs for Lane 14 and Airport Road to prevent parking in the evenings. Bower advised that the crew was still working on dust control and cleaning up around the area's that REA has been working. A discussion regarding gravel crushing was held.

Interim Planner Mike Robinson gave an update to the BOCC. A discussion on gravel crushing and chip sealing was held. Robinson advised that the current chip sealing projects were moving forward and advised they should be done around the 22nd or 23rd of July. He updated the BOCC on the Ten Sleep Rock Ranch expansion and the correspondence between the Planning Commission, DEQ and WYDOT. It was discussed that the outcome will depend on the Rock Ranch's plan on how things are done and how many people they are serving. Robinson advised that the CMAQ 2025 package is out and that it could be put together by the end of the month to submit. Anderson advised that he would like to defer to Superintendent Bower to see if he would like any changes or additions to the projects for CMAQ.
