## Washakie County School District No. 1 Budget Appropriation and Levy Resolutions

WHEREAS on the 22nd day of April 2024, the budget officer filed with the Board of Trustees of Washakie County School District No. 1 a tentative budget and budget message for the year ending June 30, 2025 and

WHEREAS, a summary of such budget was entered into the Board minutes, and notice of a public hearing on such budget together with said summary was published in the Northern Wyoming News, a newspaper having general circulation in the county in which the district is located. This was done on the 27th day of June 2024, and

WHEREAS, a public hearing was held concerning such budget on the 15th day in July at 6:00 p.m. at which time all interested parties were given an opportunity to be heard.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Washakie County School District No. 1 that such budget, as revised, is hereby adopted and, subject to future amendment, is in effect for the fiscal year ending June 30, 2025.

BE IT FURTHER RESOLVED that the following appropriations are made as of and for the fiscal year ending June 30, 2025, and that those respective expenditures applicable to each department and fund shall be limited to the amounts hereby appropriated, subject to future amendment.
