PUBLIC NOTICE

ORDINANCE NO. 847

AN ORDINANCE OF THE CITY OF WORLAND, WASHAKIE COUNTY, WYOMING, ESTABLISHING RESTRICTIONS ON REMOVAL OF SNOW FROM PRIVATE SIDEWALKS AND DRIVEWAYS AND FROM PUBLIC STREETS AND ALLEYS BY SUPPLEMENTING SECTION 19-2 OF THE WORLAND CITY CODE AND PROVIDING A PENALTY FOR VIOLATIONS THEREOF. ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH ARE HEREBY REPEALED.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WORLAND, WASHAKIE COUNTY, WYOMING.

SECTION 1: Section 19-2 of the Worland City Code is hereby supplemented as follows, to-wit (Supplements in BOLD):

19-2: DEPOSITING **DEBRIS**, **GRASS**, **LEAVES**, **LITTER**, **SNOW OR WEEDS ONTO CITY STREETS OR OTHER CITY OWNED PROPERTIES**; **REMOVAL OF SNOW FROM PUBLIC STREETS AND PROPERTY BY NON-CITY PERSONNEL**:

- **A.** It shall be unlawful for any person, business or entity, to deposit, plow, shovel, sweep or convey in any other way, onto any city street, alley, sidewalk, parking lot or other public place any debris, grass, leaves, litter, snow or weeds. Exceptions for this restriction shall be made only to those properties where it is not feasible to remove snow into any other area except the city street.
- **B.** It shall be unlawful for any non-city personnel or non-contractual personnel to remove or plow snow on any city streets, alleys, parking lots or other city properties, without being granted approval from the City of Worland Department of Public Works. This does not prohibit the removal of snow and ice from gutters if done in a manner that does not leave a deposit that interferes with the flow of traffic.
- **SECTION 2:** Section 19-16 of Article III of the Worland City Code shall be repealed in its entirety.

SECTION 3: Chapter 19 of the Worland City Code is hereby supplemented by adding the following Article IV, to-wit:

ARTICLE IV. PENALTY

19-16: PENALTY: Any person, firm or corporation who shall violate any of the provisions of this Chapter 19 shall be guilty of a misdemeanor and, upon conviction, shall be punished as provided in Section 1-7 of this Code.

SECTION 4: If any portion of this ordinance is held or found to be invalid, the remainder of the ordinance shall continue to be in full force and effect.

SECTION 5: All ordinances or parts of ordinances of the City of Worland in conflict herewith are hereby repealed.

SECTION 6: This ordinance shall take effect and be in full force and effect on MARCH 15, 2019, after having been published in the Northern Wyoming Daily News.
