## ORDINANCE NO. 873

**AN ORDINANCE OF THE CITY OF WORLAND, WASHAKIE COUNTY, WYOMING, REVISING THE EQUIVALENT DWELLING UNIT (EDU) FEE ESTABLISHED BY THE BIG HORN REGIONAL JOINT POWERS BOARD, EFFECTIVE JULY 1, 2024, BY AMENDING SECTION 23-37-4(B) OF THE WORLAND CITY CODE. ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH ARE HEREBY REPEALED.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WORLAND, WASHAKIE COUNTY, WYOMING.**

**WHEREAS**, the Big Horn Regional Joint Powers Board recently increased the Equivalent Dwelling Unit (EDU) Fee, pursuant to Resolution 2024-01, effective July 1, 2024. This fee provides for the operation and maintenance of the Big Horn Regional System and is paid by each water consumer monthly. The City of Worland pays this fee and then passes it on to the consumer.

**NOW THEREFORE**, in view of Resolution 2024-01, the City does hereby amend the City Code as follows, to-wit:

**SECTION 1:** Section 23-37-4(B) of the Worland City Code shall be and is hereby amended by adding the following revised EDU Rate Schedule to subsection B:

See **EXHIBIT "A"** attached hereto and by this reference incorporated herein for the amended EDU fee schedule.

**EXHIBIT "A"**  
**23-37-4(B) Rate & Fee Schedule:**

B: Equivalent Dwelling Unit (EDU) Fee: Each water consumer shall pay a monthly EDU fee calculated as follows:

**SECTION 4:** If any portion of this ordinance is held or found to be invalid, the remainder of the ordinance shall continue to be in full force and effect.

**SECTION 5:** All ordinances or parts of ordinances of the City of Worland in conflict herewith are hereby repealed.

**SECTION 6:** This ordinance shall take effect and be in full force and effect on **JULY 1, 2024**, after having been published in the Northern Wyoming Daily News
