The bid opening for the Worland 3-Phase Project was held on October 24, 2017 at 10:00 a.m. at City Hall. The lowest bid received was from Viper Underground at \$631,881.00 with one other bidder Western Municipal (\$830,307.00). City Engineer Representative Mike Donnell explained that the low bid was under the Engineer's estimate of \$810,884.30 and recommended acceptance of the bid of Viper Underground.

Motion: to accept the low bid of Viper Underground in the amount of \$631,881.00 for the Worland 3-Phase Project. By: Councilmember Koch.

Second by: Councilmember Schneider. Vote: The motion passed unanimously.

City Attorney Kent Richins presented a letter to send to the Wyoming Department of Transportation (WYDOT) requesting a revision to

the speed zone located on the east side of State Highway 16 East, within the city limits of Worland. The posted current speed limit is 45 MPH and the city is requesting the limit be reduced to 30 MPH due to congestion and safety issues. Discussion followed.

Motion: to approve sending the letter of request to WYDOT to change the speed limit from 45 MPH to 30 MPH on the east side of State Highway 16 East for that portion that is within the city limits. By: Councilmember Koch.

Discussion continued; Chief of Police Elliott agreed that the speed limit needed to be reduced due to heavier pedestrian and bicycle traffic, stating that the change needed to be approved by WYDOT.

Second by: Councilmember Horath.

Vote: Members voting AYE: Horath, Rideout, Schneider, Brinkerhoff, Gentzler, Gerber, Koch; Members voting NAY: Fernandez, Neufer; Members ABSTAINING: None; the motion passed by a vote of 7-2-0.

Clerk/Treasurer Tracy Glanz stated that Bentchmark Computer Consulting is terminating their contract with the city effective December 1, 2017. The IT services will be put out for bid at a later date.

Superintendent of Public Works Brian Burky reported that the city had taken delivery of the new garbage truck. There are a few items that do not meet bid specifications; these will be fixed by the provider. Once the truck is up and running it has the capacity to hold seven (7) more yards of garbage. WYDOT would like to install an information sign by Big Horn Co-op that will provide information on road closures and conditions in the canyon and is seeking the city's approval for it to be inside city limits. Discussion followed.

Motion: to approve the placement of an informational sign by WYDOT inside city limits.

By: Councilmember Horath.

Second by: Councilmember Koch. Vote: The motion passed unanimously.

Superintendent of Public Works Burky stated that Rocky Mountain Power (RMP) will put up Christmas lights over 10th Street; the city is in the process of verifying that the outlets are in good working order. Staff has been working on gathering storm sewer information specifically in those areas where the flooding occurred. We are finding outlets that are different sizes and some backflow prevention valves will have to be custom fabricated to fit the pipe. Discussion followed on maintenance of the valves; any municipality over 1,500 in population must take care of the storm sewers.

City Engineer Representative Donnell received notification from the State Lands & Investment Board (SLIB) that the application for the Culbertson Avenue Project was received and is in good order. The meeting to award grants will be held on the third Thursday in January 2018 in Cheyenne.

City Attorney Richins informed the Council that the Attorney General approved the amendment to the Joint Powers Board Agreement for the Aquatic Center.

President of the Council Gentzler requested that the city owned bus be discussed at the next Council Work Session.

Councilmembers questioned when the Parade of Lights is and when the portable toilets will be removed from the parks. The Parade of Lights is scheduled for the first weekend in December and the portable toilets will be removed soon.

There being no further business to come before the Council, President of the Council Gentzler asked for a motion to adjourn.

Motion: to adjourn the meeting at 7:28 p.m. By: Councilmember Rideout. Second by: Councilmember Horath. Vote: The motion passed unanimously.
