Donnie Bjorhus with Green Hills Golf Course reported that there were 1,442 rounds played in September; this number does not include the two days of the 3A State Tournament. The Worland City Open Championship was held on September 9-10 and the annual Ryder Cup/Solheim Cup was September 30, 2023. Green Hills also hosted the Middle School/High School Cross Country meet on Thursday, September 28, 2023. The course received a great deal of compliments from the players, coaches and spectators of the 3A State Tournament. The maintenance staff has done a tremendous job with the course this year and will be busy with leaf clean-up as well as getting the course and irrigation system ready for the winter months. Mayor Gill and Director of Public Works Nick Kruger thanked the Council and public for their support and financial contribution to the golf course. It has enabled city staff and Mr. Bjorhus to improve the course, sprinkler system (pressure issues) and purchase needed equipment.

Sandy Tibbs with the American Cancer Society invited the Council and community to Paint the Town pink for Breast Cancer Awareness month, especially on October 20th, National Mammography Day. Ms. Tibbs also requested approval to use Pioneer Square for the event on October 20, 2023 from 10-6PM. Pink décor will be added to the park for the day using silk flowers, streamers and a pink flag. Participants who wish to walk celebrating as a breast cancer survivor or take a stroll for someone fighting it now, would use the sidewalk around the Square, through the path or walk downtown to local businesses. The sitting area by the library box would be used for check-in purposes.

Complex Task Force meeting in Riverton last week. It was a good meeting, and the legislators were very forthright in that they do not have all the answers yet for the prospectus. Presentations were given by the Town of Thermopolis, City of Cody, City of Worland and Fremont County for consideration by the committee.

City Engineer Representative Mike Donnell provided information received today on the Washakie Avenue Project. The email from WYDOT indicated that the City will be subject to the project abandonment clause. This clause says a portion of the project must go to construction within two (2) years after the completion of the design or the project is considered abandoned. If construction is not started within that period the city would have to reimburse WYDOT for the entire cost, including any federal aid portion of the work completed at the time of abandonment. The estimate just for design of the project will use most of our urban systems funds through WYDOT. As stated in the past, the City/County share of this project is 9.51% with the city paying half and county paying half of that local match. Mayor Gill stated that the Urban Systems Committee needed to schedule another meeting to discuss the issue further. City Engineer Representative Donnell mentioned the legislative representative tour scheduled for next week and noted that such a tour would be valuable for Councilmembers as well. Mayor Gill agreed and stated a tour for Councilmembers had been done at a Council Work Session.

Director of Public Works Nick Kruger reported on the leak on the line from the east water tank into town (mentioned at the last Council meeting); the crew did not find a leak in the line. As soon as the crew dug where the water was, it disappeared. Public Works will continue to monitor the site to see if water comes to the surface. There is a leak in Country Heights; the leak has been fixed and the crew will finish the project later this week. The park's restrooms will stay open, as nicer weather allows. Director of Public Works Kruger passed out a map of the cemetery requesting that the Council allow Block 84 to be opened. It is currently closed by ordinance. A family is requesting to purchase an entire Lot and the older part of the cemetery does not have that many graves available in one spot. Discussion followed on opening more than just this one block. Concerns are maintenance issues and that the southern section of road in the cemetery is not currently maintained. Additionally, each area or garden has specific requirements, so opening the whole cemetery would require additional work to come up with those requirements per block. Discussion continued. Councilmember Neufer asked how many graves are available in the current open blocks. Director of Public Works Kruger estimated that 60% of the graves are sold with actual burials at approximately 50%. Councilmembers agreed that more than Block 84 should be opened.
