A motion was made by Commissioner Wolf and seconded by Commissioner Martinez to approve the purchase of the angled box from Bobcat for snow removal. Motion carried.

Road and Bridge Superintendent Stuart Bower gave an update to the BOCC. He advised that gravel is being hauled up to Big Trails, they will do Cherry Creek loop again and Rome Hill will also be taken care of. A discussion was held on the need for the Airport Road culvert to be taken care of as the cost to dig it up and replace it was too great compared to the quick fix and longevity of repairing it.

A motion was made by Commissioner Martinez to approve Subsurface, Inc. to do the culvert in the amount of \$36,160.00

Interim Planner Mike Robinson gave a planning update to the BOCC. A discussion was held regarding chip sealing and all of the potential areas that would benefit from it. Chairman Anderson advised that he would like to see some of the roads that haven't been worked on to be chip sealed with some of the discussed funds. Robinson advised that the CMAQ is in process and potential crushing pits were also discussed. An update on Red Vista Village was given by Robinson and he advised that the roadway needed to be adjusted to fit the easement and that there has been no final word regarding the water supply.

A motion was made by Commissioner Wolf and seconded by Commissioner Martinez to approve the M&N Subdivision. Motion carried.

A motion was made by Commissioner Wolf and seconded by Commissioner Martinez to approve the grant application submission for the library expansion with the estimated costs. Motion carried

Jerry Kysar presented an issue of damaged private property in which he believed that the accused needed to be prosecuted, to the BOCC. The Commissioners advised Kysar that due to the limited time to review the issue, they would like to speak with Sheriff Brookwell and get a full perspective on the issue. County Attorney Barton advised that due to the fact that there was no malicious intent and it was simply accidental, the issue was not considered property destruction. Barton also stated that there were no indicators as to a crime being committed so no criminal action could be taken. It was advised that he take it up in small claims court.

Fire Warden Chris Kocher presented the CAFA Gold Mine Project to the BOCC. The bid advertisement was read aloud by Chairman Anderson. Kocher advised that there was only one bid received which was from Technical Forestry Services, LLC.

A motion was made by Commissioner Wolf and Seconded by Commissioner Martinez to approve the bid from Technical Forestry Services, LLC in the amount of \$20,500.00 for the CAFA Gold Mine Project. Motion carried.

Kocher gave a rundown of the fire season to the BOCC. He advised that they will be doing a project with the University of Montana on the Nature conservancy for a Cheatgrass Study. They will be doing 8 small burns in conjunction with the study. Kocher said that he anticipated next year's fire season to be busier than usual as well

There being no further business to come before the BOCC a motion was made by Commissioner Wolf to adjourn the meeting at 3:54 pm. Motion carried.
