After voting, ballots are to be returned to the Washakie County Conservation District or South Big Horn Conservation District by mail or delivered in person to the Washakie County Conservation District Office at 208 Shiloh Road, Worland, WY, 82401, or to the South Big Horn Conservation District at 408 Greybull Avenue, Greybull, WY 82426. **PEASE READ CAREFULLY: Mail Ballots for Washakie County must be received by 5:00 p.m. on November 7, 2017. Mail Ballots for Big Horn County must be received by 4:00 p.m.**
