Ambulance Assistant Director Gard Ferguson met with the board to discuss replacing the director of the ambulance service due to the death of current director Mike Bryant. Discussion was held on how scheduling had been handled for the past several months. Gard will review the current job description and make any necessary changes that may be needed before the board moves forward with advertising. The board thanked Gard for him taking on the role of director for the last nine months.

Public Health Nurse Amanda Heinemeyer reported to the board that the current nurse practitioner has received full time employment with Red Rock Family Practice. Red Rock is willing to work with Public Health to allow the nurse to have four clinics per month for Family Planning. Approval was given by the board to have the county attorney review a contract for this arrangement. Amanda reported that there is still a question if Title X funding will be available next year. If not, medications can still be purchased at a discount through the State of Wyoming referral.
