Public Health Coordinator Amanda Heinemeyer requested that the current, grant funded, Public Health Response Coordinator part-time position be changed to a full-time position. She advised that benefits could then be offered in which the grant would cover. The BOCC approved the position change and for Washakie County to provide the payroll services to the position as it is grant funded and all will be reimbursed.

Road and Bridge Superintendent Stuart Bower gave an update to the BOCC. He advised that the crew is currently moving materials from pits to finish graveling roads as needed throughout the county. Bower said that they will be doing more pothole patching as well as the warmer weather continues to hold up.

A discussion was held with County Attorney Tony Barton regarding Title 25 invoices from Banner Health. Barton elaborated on the need for Banner to contact Oxbow regarding potential Title 25 patients in order to prevent elaborate bills to the county for patients that could possibly be transferred to the Oxbow Center.

He advised that the two entities have largely stopped working together with the result in a significant raise in Title 25 cases that costs the County significantly more than if they were to be transferred to the Oxbow Center.

Building Maintenance Manager Breck Buer gave an update to the BOCC. He advised that he has been working on minor repairs in the County Buildings that have needed attention. Buer said that the new fire alarm system at the VA building has been installed and is now properly functioning. He also advised that he will be continuing to do the upkeep on the Airport Road Bike path. A discussion was held regarding the Ambulance Service needing to be completely moved out of the Public Health building soon.

A motion was made by Commissioner Wolf and seconded by Commissioner Martinez to approve the revisions to the Washakie County Employee Policy Manual. Motion carried.

A motion was made by Commissioner Wolf and seconded by Commissioner Martinez to approve the Malt Beverage application for Gooses Liquor to serve at a private event in Ten Sleep. Motion carried.

Franklin advised that they were currently in the process and will be moved out within a week and a half. A discussion was held regarding the service and Commissioner Wolf asked if the ground service had picked up any since their last discussion. Franklin advised that it had not. He said that the services had not cut back any, and were mostly the same.

There being no further business to come before the board, a motion was made by Commissioner Martinez and seconded by Commissioner Wolf to adjourn the meeting at 12:15 pm. Motion carried.
